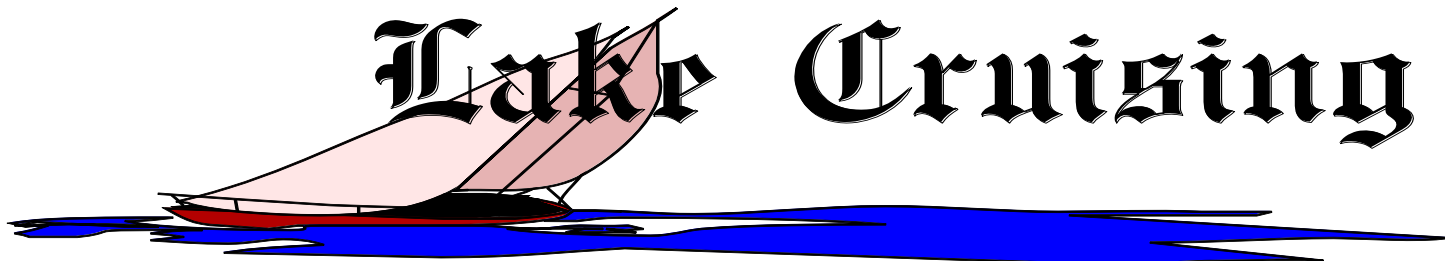

ANNUAL MEETING

At the annual meeting in April the association finally was able to hold its' election. Since this was the first election in three years all nine positions were on the ballot. There were only nine candidates. This placed the election under the by-laws provision for a non-contested election so each candidate had a yes or no vote.

A total of 190 ballots were mailed out to all the members in good standing. We received 85 ballots back. Under provisions set by the court the count was held in the open and observed by attorneys for each side in the lawsuit. One ballot was disqualified leaving a total of 84 ballots voting. After the Board elections were announced the annual meeting was adjourned. At this time the election of board President was announced.

There were two candidates for this position Beverly Bodiford **17** votes and Joe Summerlin **66** votes making Joe Summerlin the victor.

Since there were still 3 remaining positions available, the board allowed candidates interested in serving on the board to turn in bios. Out of those candidates 3 members were appointed by the board (as per the by-laws). The candidates that lost due to the non-contested election procedure (bylaws) could not be placed on the board.
